We are attorneys for Plaintiff Energetic Tank, Inc., owner of the M/V ALNIC MC ("Owner"), in the referenced matter. We write to request that the Court extend the deadline for the crew members and families of deceased crew members of the USS JOHN S. MCCAIN to file claims by sixty days from April 16, 2018 to June 15, 2018. There have been no prior requests for extensions.

To supplement the notice requirements of Rule F (4) of the Supplemental Rules for Certain Admiralty and Maritime Claims of the Federal Rules of Civil Procedure, the U.S. Navy has voluntarily undertaken to arrange to provide the Notice of Complaint for Exoneration from or Limitation of Liability to the service members on board the USS JOHN S. MCCAIN at the time of the collision and the families of the service members who died as a result. That process may not be completed prior to the presently scheduled claims deadline.
